SECTION 4: FIRST-AID MEASURES

Inhalation	Remove the casualty to fresh air and keep at rest in a position comfortable for breathing. If breathing is difficult, give oxygen. If breathing has stopped, give artificial respiration. Obtain medical attention.

Suitable Extinguishing Media	Alcohol-resistant foam, dry chemical powder, carbon dioxide (CO ₂). Water spray may be used to cool containers — do not use a direct water jet, which may spread the fire.
Unsuitable Extinguishing Media	High-pressure water jet.
Specific Hazards	Vapours are heavier than air and may travel along the ground to a distant ignition source and flash back. Containers may explode when heated.
Advice for Fire-fighters	Wear self-contained breathing apparatus and full protective clothing. Prevent fire-fighting water entering drains or watercourses.

Environmental Precautions	Prevent entry into drains, sewers, surface water and groundwater. Notify the relevant authorities if release to the environment occurs.
