SECTION 4: FIRST-AID MEASURES

Inhalation	Remove the casualty to fresh air and keep at rest in a position comfortable for breathing. If breathing is difficult, give oxygen. If breathing has stopped, give artificial respiration. Obtain medical attention.

Suitable Extinguishing Media	Water spray, dry chemical powder, carbon dioxide (CO ₂) or alcohol-resistant foam.

Environmental Precautions	Prevent entry into drains, sewers, surface water and groundwater. Notify the relevant authorities if release to the environment occurs.
Containment & Cleaning	Contain the spill with an inert absorbent (dry sand, earth or vermiculite). Collect into a labelled, closed container for disposal.
