SECTION 4: FIRST-AID MEASURES

Suitable Extinguishing Media	Water spray, dry chemical powder, carbon dioxide (CO ₂) or alcohol-resistant foam.

Personal Precautions	Evacuate unnecessary personnel. Ensure adequate ventilation. Wear the personal protective equipment described in Section 8. Eliminate all ignition sources where the product is flammable.
Environmental Precautions	Prevent entry into drains, sewers, surface water and groundwater. Notify the relevant authorities if release to the environment occurs.
Containment & Cleaning	Contain the spill with an inert absorbent (dry sand, earth or vermiculite). Collect into a labelled, closed container for disposal. Conditions for Storage	Store in the original, tightly closed container in a cool, dry, well-ventilated place away from direct sunlight and heat. Keep away from incompatible materials listed in Section 10. Store in a bonded area where liquids are held.
