SECTION 4: FIRST-AID MEASURES

SECTION 5: FIRE-FIGHTING MEASURES

Suitable Extinguishing Media	Alcohol-resistant foam, dry chemical powder, carbon dioxide (CO ₂). Water spray may be used to cool containers — do not use a direct water jet, which may spread the fire.
Unsuitable Extinguishing Media	High-pressure water jet.
Specific Hazards	Vapours are heavier than air and may travel along the ground to a distant ignition source and flash back. Containers may explode when heated.
Advice for Fire-fighters	Wear self-contained breathing apparatus and full protective clothing. Prevent fire-fighting water entering drains or watercourses.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions	Evacuate unnecessary personnel. Ensure adequate ventilation. Wear the personal protective equipment described in Section 8. Eliminate all ignition sources where the product is flammable.
Environmental Precautions	Prevent entry into drains, sewers, surface water and groundwater. Notify the relevant authorities if release to the environment occurs.
Containment & Cleaning	Contain the spill with an inert absorbent (dry sand, earth or vermiculite). Collect into a labelled, closed container for disposal. Do not use combustible absorbents such as sawdust where the product is an oxidiser. Ventilate the area and wash the spill site after material pick-up.

Conditions for Storage	Store in the original, tightly closed container in a cool, dry, well-ventilated place away from direct sunlight and heat. Keep away from incompatible materials listed in Section 10. Store in a bonded area where liquids are held.
